RESOLUTION 2001-01
TO
VACATE LAND IN THE VILLAGE OF HEWITT

Final Resolution to Vacate the following 2 parcels of property located in the Village of Hewitt, Wood County, Wisconsin.

Parcel #1 – The far East portion of Evergreen Street that was originally proposed for a roadway: Beginning at the SW corner of Lot 14 of Draxler Estates, Village of Hewitt, Wood County, Wisconsin; Thence N 88°- 47'- 45" E along the South line of Lot 14, 100 Feet to the SE corner of Lot 14; Thence S 0°-11'-30" W 60.01 Feet to the NE Corner of Lot 30, of the First Addition to Draxler Estates, Village of Hewitt; Thence S 88°-47'-45" W along the North line of Lot 30, 110 Feet to the NW Corner of Lot 30; Thence N 0°-11'-30" E 60.01 Feet; Thence N 88°-47'-45" E 10 Feet to the Point of Beginning.

Parcel #2 – Eleventh Street and the far West portion of Evergreen Street that was originally proposed for a roadway: Beginning at the SW corner of Lot 97 of the Second Addition to Draxler Estates, Village of Hewitt, Wood County, Wisconsin; Thence N 89°-25'-06" W 30 Feet to the Point of Beginning; Thence N 0°-01'-28" W 1023.44'; Thence S 89°-34'-56" E 30 Feet; Thence S 0°-01'-28" E 123 Feet; Thence S 89°-34'-56" E 145.64 Feet; Thence S 0°-01'-28" E 60 Feet; Thence N 89°-34'-56" W 145.64 Feet; Thence S 0°-01'-28" E 840.53 Feet to the Point of Beginning.

WHEREAS

The Village of Hewitt board having held a public hearing at the Hewitt Village Hall on July 10th at 6:30 PM on the matter, after notice thereof having been duly published in the official newspaper according to law, and after adjacent property owners of the land to be vacated have been notified by certified mail, and all parties desiring to be heard having been heard.

WHEREAS

When the once said parcels of land described above are vacated by resolution, they are by Statute returned to the original owner if known and/or alive. In this case the 2 parcels described above will be returned to Ida Draxler, 7925 Yellowstone Drive, Hewitt, WI, 54441.

NOW THEREFORE, BE IT RESOLVED

By the Village Board of the Village of Hewitt, Wood County, Wisconsin, by a majority vote approved the following Resolution 2001-01 to Vacate the 2 Parcels of Land described above.

This Resolution shall become effective immediately upon passage.
