# Hewitt Area Recreation Department Minutes

Date: Tuesday – August 18, 2015

The meeting was called to order at 6:30 PM at the Yellowstone Recreation Park.

The treasurer's report for August 18, 2015 was reviewed; ending balance \$29,302.98. A motion to accept the treasurer's report was made by Cheryl Uthmeier, second by John Phillippi. Motion Carried.

### Old Business

- Softball & Volleyball wrap up and improvements for 2015. All leagues reported having a good season. Suggestions and needs are:
  - Work needed on fundamentals.
  - Consider putting 1<sup>st</sup> names on the shirts for the 9-11 year olds.
  - Re-grip bats.
  - Help to get coaches for the 12-14 softball league.
  - Start the 12-14 softball tournament games earlier.
  - In addition to the website, handout the volleyball forms to the schools.
- Team pictures were about the same as last year. Approximately 40 individual pictures were taken.
- Concession stand sales were good, new registers need to be purchased. Consider purchasing our own coolers for next season.
- Raffle went well and the sales were slightly higher this year.
- Beer stand sales were a little less compared to last year as was the crowd.
- Music suggestion for next year was to hire a live band.

### New Business

- Motion by Scott Wunrow, second by Jeff Binder to pay \$250.00 for sponsorship to the HAFD Pumpkin Run. Motion Carried.
- Motion by Scott Wunrow, second by Phyllis Kollross to purchase a \$200.00 gas card and give to Marlene Kappel for the trips she makes to Sam's Club and other stores to purchase items for the concession stand. Motion Carried
- Motion by Tacey Doine, second by Joanne Binder to donate \$1,800.00 in 2016 to the Village of Hewitt to help pay for the maintenance of the park.
- An email will be sent out in October for a work night to put away baseball signs, bases etc.
- The 2015 Christmas Party will be December 12, 2015 at the Village Inn in Hewitt. More information on this party will be sent in an email in November.
- The 2016 softball/volleyball season will be May 31 – July 26, 2016. Tournament weekend is July 29-30, 2016.

- There was no AED training – schedule for next year.

There was discussion on improvements needed.

- Motion by Deb Lang, second by Tacey to purchase a new volleyball net for the Village Hall volleyball court. Motion Carried.

- Motion by Scott Wunrow, second by Karen Tritz to hire Bob Beining to plant seed and fill in areas on the ball park where needed and invoice the Hewitt Area Recreation Department for these services. Motion Carried.
